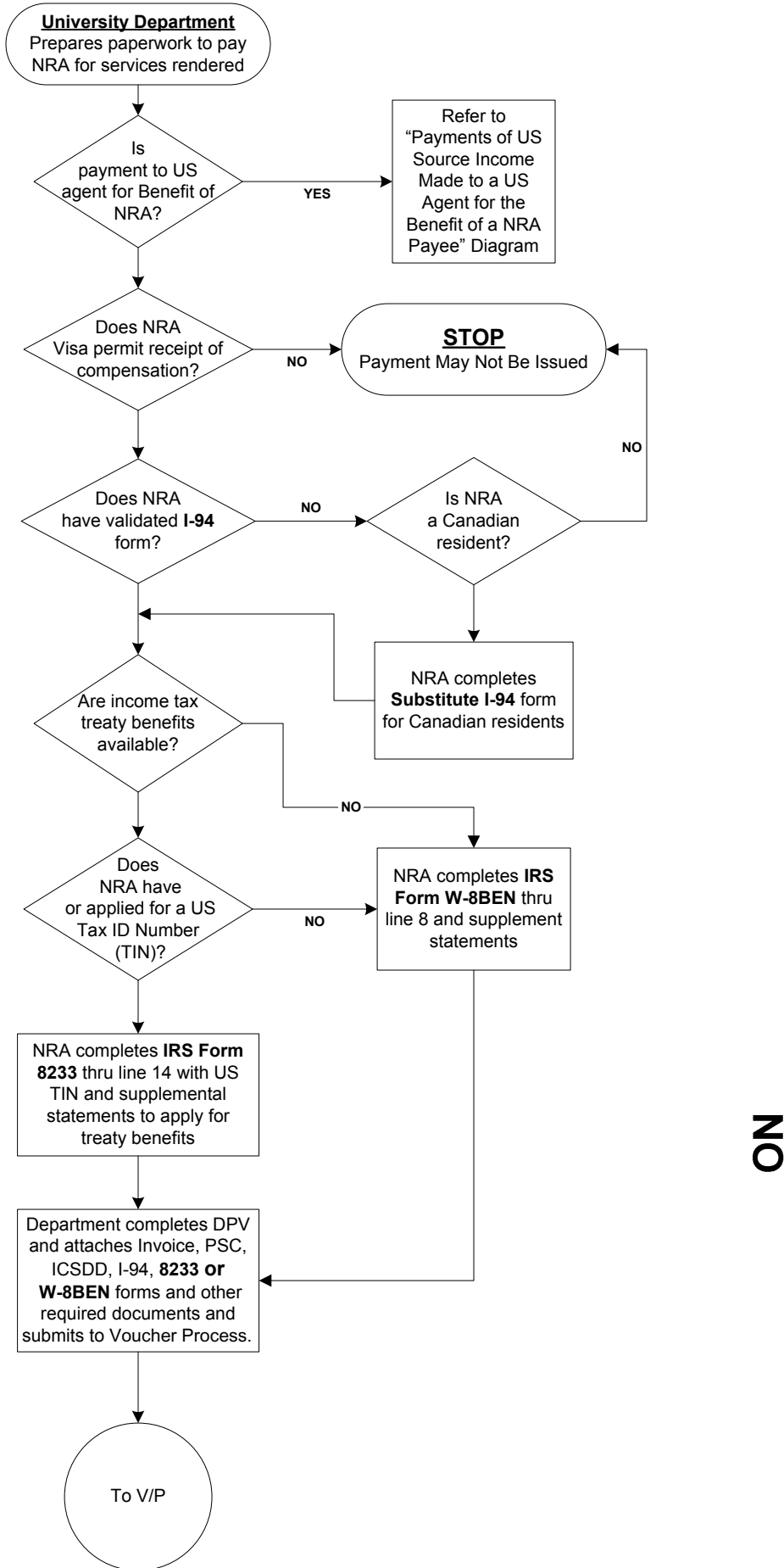

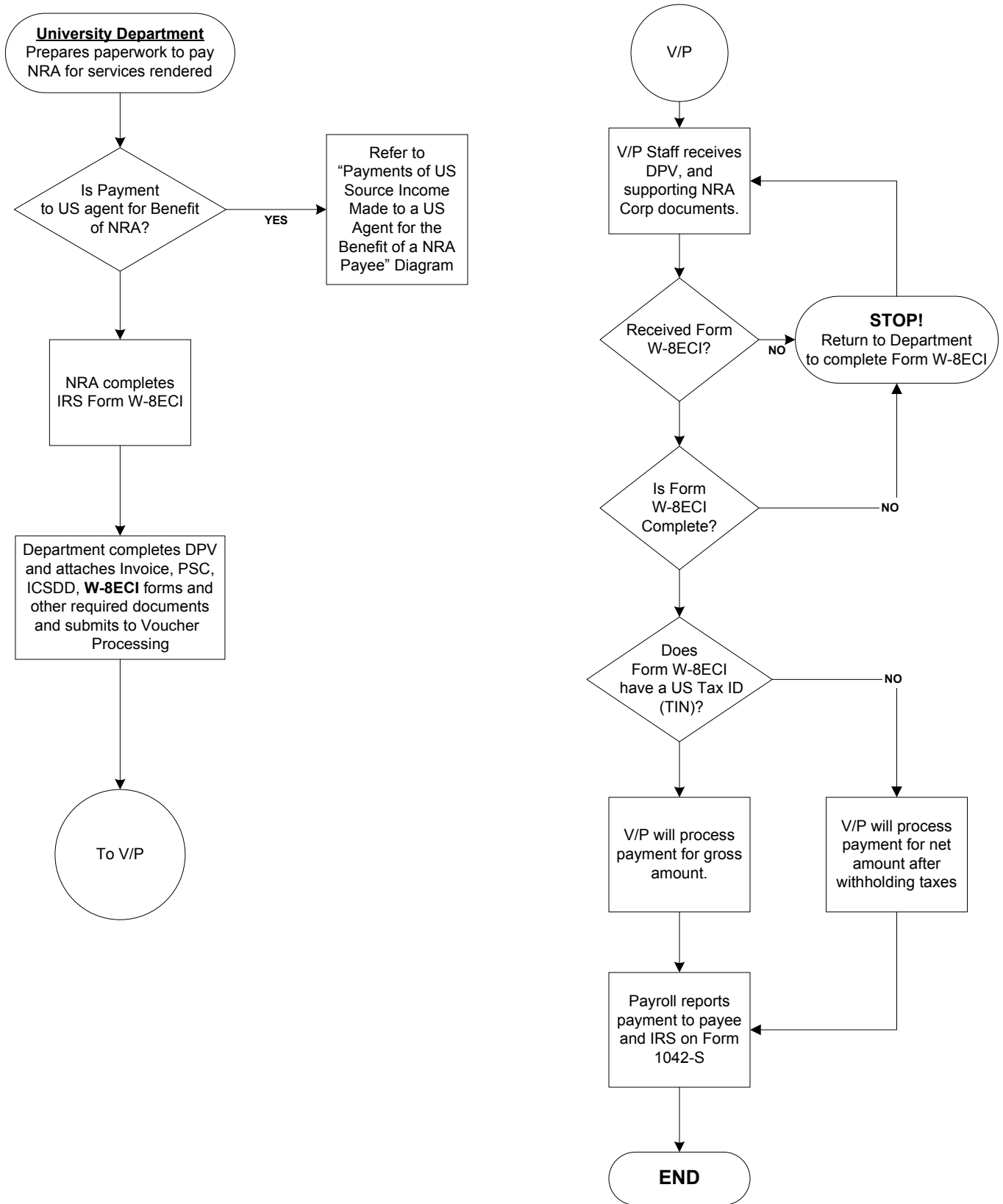

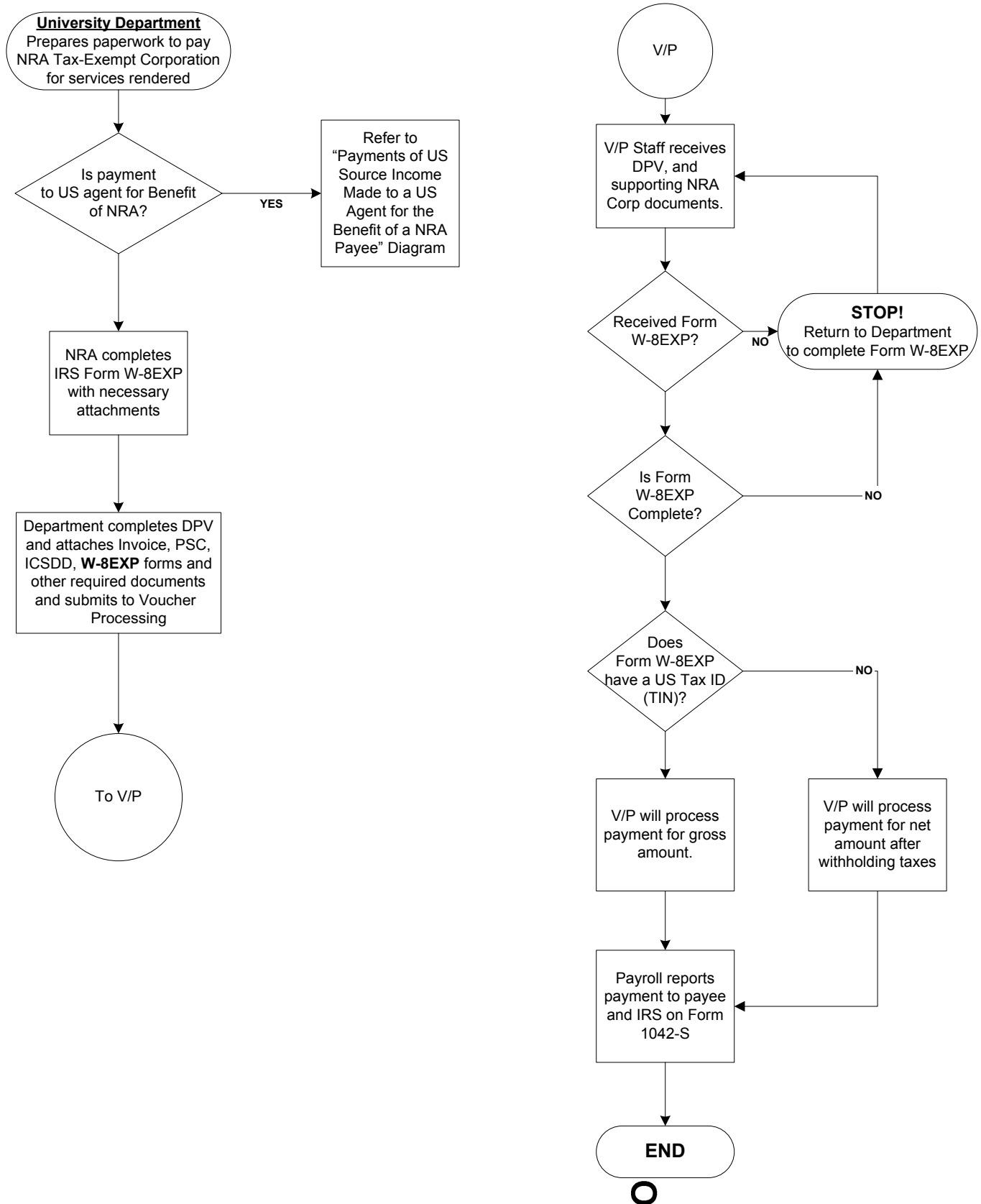
# Compensation for Service rendered in the USA by a NRA Corporation, Partnership or Fiduciary

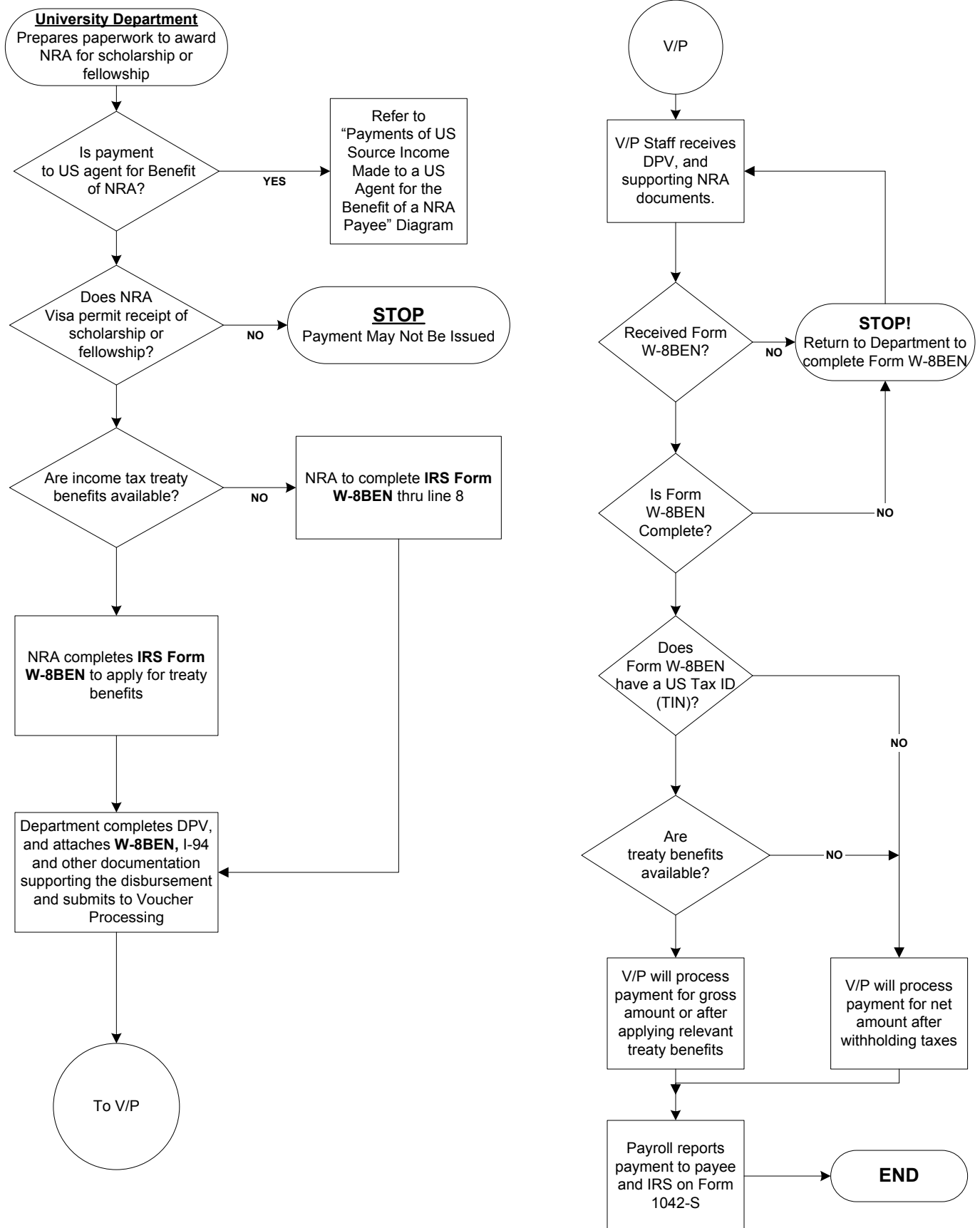
# Compensation for Service Rendered in the USA by a NRA Tax-Exempt Corporation

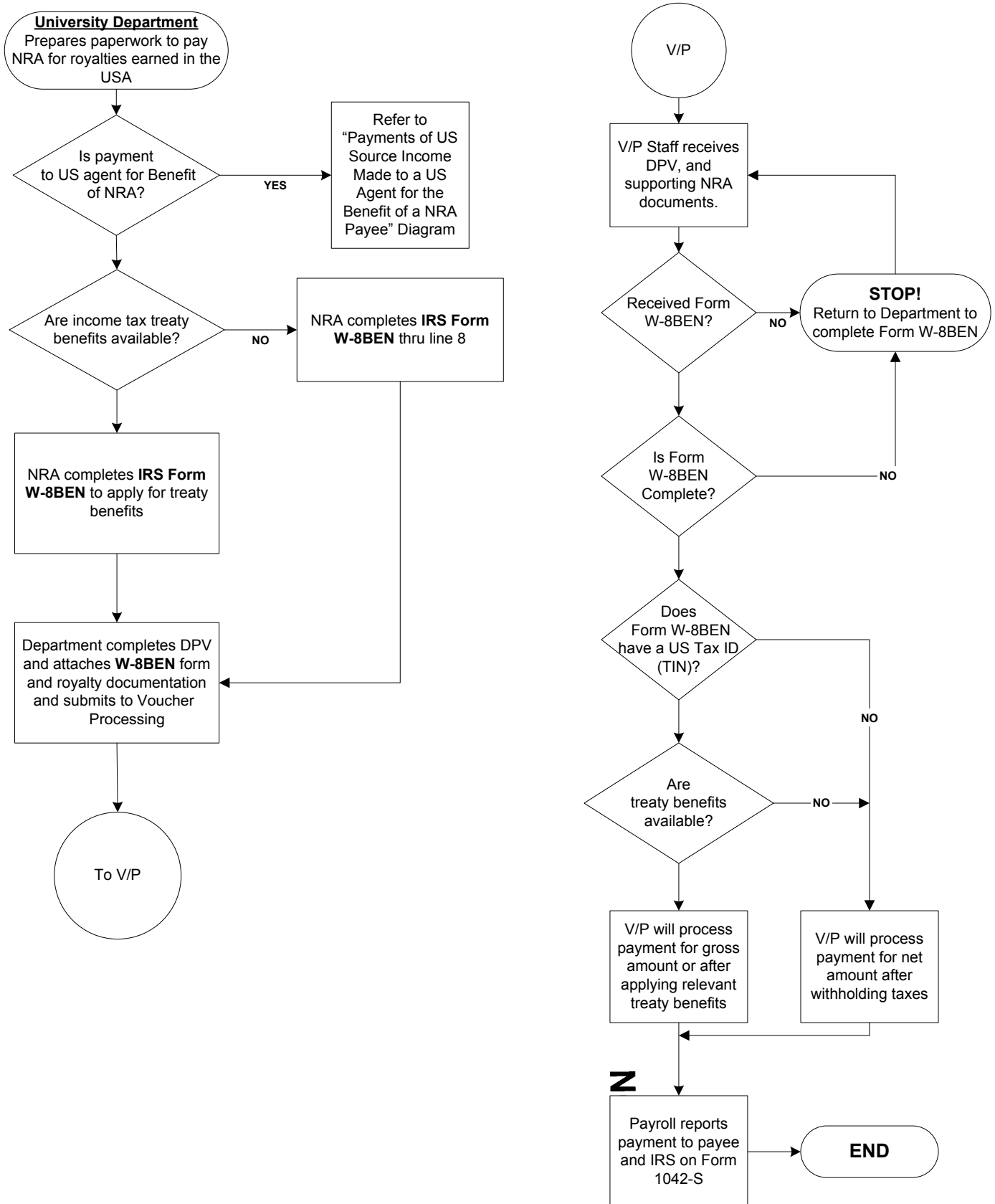
# Scholarship or Fellowship Award Issued to NRA Individual Not Enrolled in a Degree Program

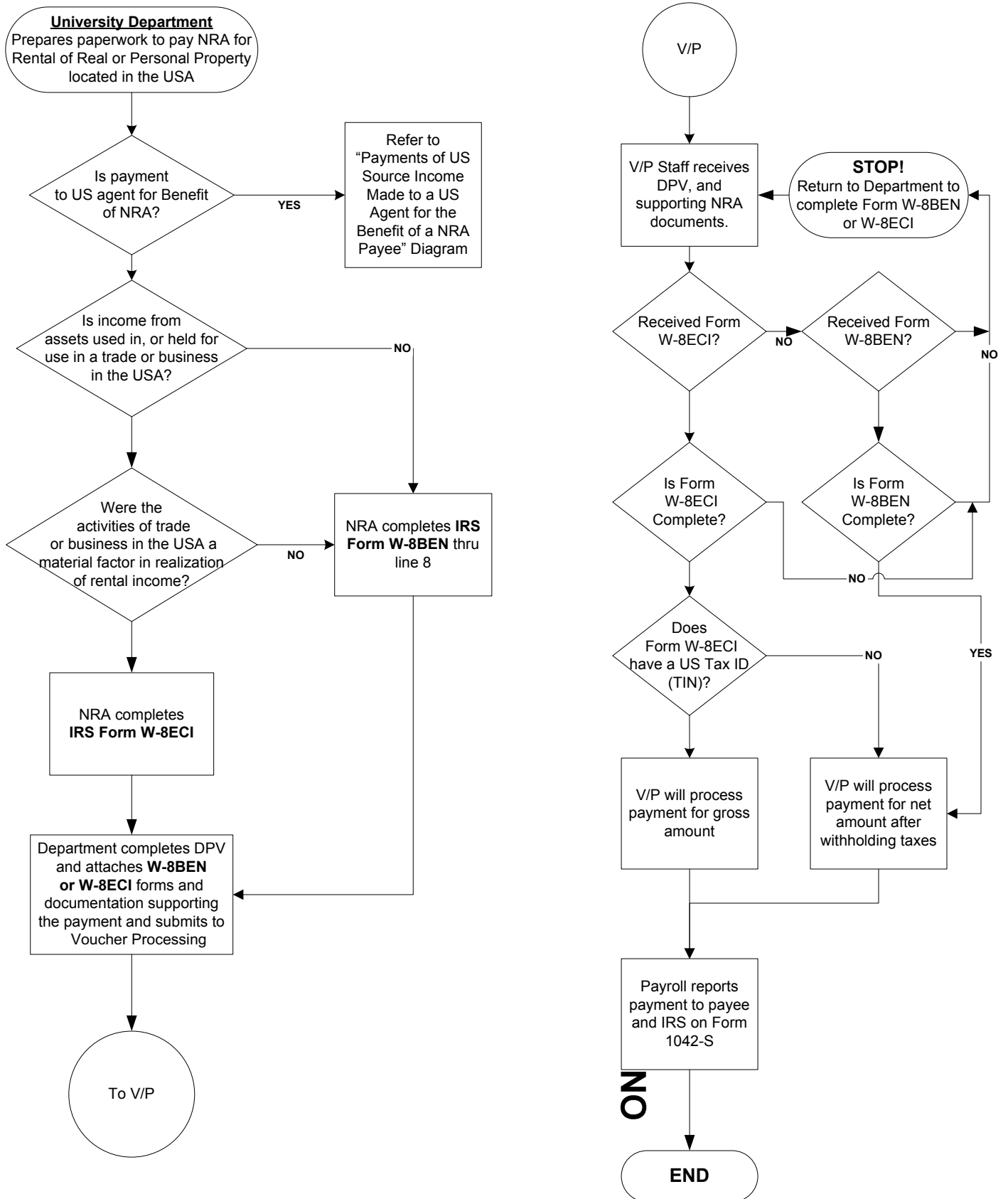
## Payment to NRA of Royalties Earned in the USA
